Description of Work

Typing Software Services for Hindi, English Typing, and Typing of English and Hindi Shorthand Transcription with Operational Support During the Exam.

Scope of Work:

The scope of work for "Typing Software Services for Hindi, English Typing, and Typing of English and Hindi Shorthand Transcription with Operational Support During the Exam" is as follows.

- 1. Firm will design and develop the typing software for Hindi, English Typing, and Typing of English and Hindi Shorthand Transcription.
- 2. Each exam will have separate customized software.
- Each exam may have separate requirement i.e one exam may have only English Typing other exam may have both Hindi & English Typing etc. Typing Software will be customized as per exam requirement.
- 4. Fonts for the Hindi Typing will be Kruti Dev 010 and Times New Roman for English.
- 5. Software should be LAN based application that will have the facility to upload the exercise from the server.
- Software should have the timer facility and once time is over software should get closed automatically. Two minutes demo for typing before the start of the typing exam should also be there.
- 7. Software should have the facility to store the candidate details in a database server and will be accessible in all the systems of the LAB through LAN.
- 8. Software should have the facility to upload the instruction for that particular exam, which will be displayed to candidates before the exam.
- 9. Software should have the facility to log in with the help of a roll number. After login candidate should be able to see his/her details.
- 10. Software should have the facility to calculate the typing speed based on the formula/criteria. The different exams may have different formula/criteria for calculating typing speed.
- 11. Software should have the facility to save the typed content in the database and also generate the typed content in a non-editable secured pdf file, which should be saved in the local machine as well as on the server.
- 12. Software should have the resume facility, in case of a system failure or any other system error.
- 13. Software should be robust and error-free.
- 14. Firm will have to provide the software to UKPSC at least 30 days before each scheduled exam to check the functionality of the software.

- 15. Firm will have to provide 1 technical person for every 60 candidates during the exam to provide operational support during the exam.
- 16. Any other work as per the requirement of UKPSC.

Earnest Money Deposit(EMD)

EMD Rs.80,000/- shall be deposited in the form of FDR pledged in the favour of Secretary, UKPSC, Haridwar. EMD should be valid for 45 days beyond the bid validity.

Performance Security:

The successful bidder will have to deposit performance security of Rs. 2,00,000/- in the form of FDR pledged to Secretary UKPSC, Haridwar or Bank Guarantee issued by the Bank. It should be valid beyond 60 days of contract period.

Instructions to the Bidders:

Period of Contract:

(a) The contract shall be initially for a period of 01 years or till the date of existence of the new contract.

(b) In case the performance is not found to be satisfactory or not in conformity with the terms and conditions of the bid document, the contract shall be terminated even before the scheduled time as per sole discretion of <u>UKPSC</u>.

(c) In the event of premature closure of contract for reasons mentioned herein above, the Security Deposit shall be absolutely forfeited along with penalty as decided by the UKPSC

Eligibility Criteria:

- (a) Firm/Agency should be registered under Company act 1956/2013 or Partnership firm or proprietorship firm and should also be registered with appropriate tax authorities such as Income Tax, and GST and should submit valid certificates of registration with these authorities. Also, fill out Annexure 1.
- (b) The agency/firm should have a minimum of 3 years prior experience in providing Hindi & English Typing and English & Hindi Shorthand Transcription Typing Software Services to Government/Commission/PSU clients for more than 10 thousand candidates. Work Order/Completion Certificate in the name of bidder should be submitted along with the Bid.
- (c) The bidder should not have been blacklisted by Central/State Government Departments/Undertakings. An affidavit in this regard must be submitted along with Technical Bid.
- (d) Bidder cannot outsource the work to any other agency.

Payment Terms:

- (a) For Typing Software/Steno Transcription Typing Software, firm will be paid on the basis of generated admit cards against the shift.
- (b) One technical person will be deployed by the firm. Payment for Technical Person will be made on day basis, one day before the exam and also during the exam days.
- (c) No advance payment shall be made to the firm.

General Terms & Conditions:

- 1. In view of the nature of the work, UKPSC expects 100% error-free work.
- 2. No interest on the Earnest Money or Security deposit shall be paid by the UKPSC to the bidder.
- The UKPSC does not pledge itself to accept the lowest or any other bidders and reserves to itself the right of accepting the bidders wholly or in part keeping in view valid reasons. Conditional bidders will not be accepted.
- 4. Only those firms who will qualify in the technical bid will be considered for financial bid(s).
- 5. No advance payment shall be made to the firm. The firm will generate the invoice after the completion of the exam.
- 6. The penalty of the minimum amount of 10% of the bill will (excluding GST Amount) will be charged for technical/manual discrepancy.
- 7. Bidder will be responsible for the security of the typing software.
- 8. The contract has been entered into the State of Uttarakhand and its validity, construction, interpretation, and the legal matter shall be subject to the exclusive jurisdiction of the Courts of Uttarakhand.
